2.3 **Maintenance.** Tenant will maintain the Property in a good and organized condition, including, without limitation, free of trash, debris, and unused equipment.

2.4 **Improvements.** Tenant may not place sheds, hoop houses, or otherwise install permanent or movable structures on the Property without first obtaining Landlord's written approval. Landlord will not unreasonably withhold such approval.
